CCDSC is available for group rentals (3+ people), special events and instructor rentals. The following rates apply:

Large Arena Rental:

\$40 per hour
or
\$350 for 8+ hours/day

Rental comes with access to:

- * The Large Arena (60 x 128 + 12 x 36)
- * One enclosed room for crating
- * Access to empty stalls for crating
- * All standard agility equipment
- * Parking
- * Up to 4 tables (8')
- * Up to 12 chairs
- * Access to the two small potty yards
- * Access to the onsite photo booth

Small Arena Rental:

\$30 per hour
or
\$260 for 8+ hours/day

Rental comes with access to:

- * The Small Arena (60 x 40)
- * One enclosed room for crating
- * Access to empty stalls for crating
- * Agility equipment access
- * Parking
- * Up to 4 tables (8')
- * Up to 12 chairs
- * Access to the two small potty yards
- * Access to the onsite photo booth

Small and Large Arena Rental + Meeting Room:

\$60 per hour
or
\$500 for 8+ hours/day

Rental comes with access to:

- * All items listed in small and large arena rentals
- * Use of the 24 x 30 enclosed, matted room

Instructor and Group Rates

POLICIES FOR GROUP RENTALS

Our goal with these policies is to keep everyone safe and our premises clean! Users of CCDSC will need to adhere to the following:

At least one individual must sign a rental agreement and be responsible for the deposit and payment.

Deposit for special events: a deposit of 1/3 the rental price to hold dates at least 2 months in advance or when the event is booked. This deposit is non-refundable and may only be exchanged for a future event in the case of a weather emergency closing the facility. The remainder of the fee is due at least 5 days prior to your event.

Instructor rent: for ongoing classes, rent will be due monthly, starting on the first day of classes and on that same date each month after that.

The responsible party must enforce the rules of CCDSC, which are posted on our website and onsite.

The responsible party must ensure that all individuals have signed a CCDSC Liability Waiver within the current calendar year. Best practice is to have all attendees sign the waiver before each event/class.

Due to insurance limitations, users may not practice bite sports or protection sports of any kind.

Users must inform CCDSC immediately of any broken equipment or concerns with the buildings or property.

No outdoor, amplified music or announcing is allowed, per county restrictions.

The responsible party must walk the premises for discarded trash or dog poop and dispose of it in the proper receptacles onsite. Users who are found to regularly leave the site in disarray may be subject to a cleaning fee and not allowed to return for future rentals.

Instructors or clubs holding classes or sanctioned events must provide insurance.
